## Housing Grant Submission Guidelines

To nominate a local charity, each local REALTOR® association must submit the Foundation's official, two-page grant application. The application has been formatted so text can be entered directly on to it. If you are using Adobe Acrobat, you can click the submit button when finished and it will be emailed directly to the Foundation. If using a different pdf reader, the application can be saved and emailed directly to MAR Communications / Media Production Manager, Eric MacDougall at [mac@marealtor.com](mailto:mac@marealtor.com). All charitable organizations must submit applications to a Local Association for initial review prior to the application being received by MAR. The current list of Local Associations can be found at <https://www.marealtor.com/about/local-realtor-associations>.

Applications may be accompanied by additional literature or materials that demonstrate the impact a nominated charity has had within the community or local market area. However, applications that are supported by such documents will not be weighted more heavily than those that do not.

In completing the grant application process, it is important to provide as much detail about the activities and services offered by the nominated non-profit group as possible, particularly how the charitable organization aligns with the MAR Charitable Foundation's mission of providing assistance for disaster relief and housing related causes.

In addition to submitting the application via email, the application can be printed and mailed to: Eric MacDougall, MAR Charitable Foundation, 333 Wyman Street, Waltham, MA 02451. However, emailing is strongly preferred to avoid receiving a grant after the deadline has passed.
