

Proposed Governance Restructure - Committee Structure

Committee: Appointed or selected to perform a function on behalf of a larger group, meeting regularly each year.

Subcommittee: Breakout of a committee to work on a certain area of the group's responsibility.

Work group: A group of individuals assigned to work together toward an outcome.

Task force: Experts in specified areas of knowledge or practice brought together to accomplish a specific objective.
